

MEMORANDUM OF UNDERSTANDING

This Student Affiliation Agreement (the "Agreement") is entered into as on 01/09/2024 by and between **Himalayan University, Jollang, Itanagar – 791111, Arunachal Pradesh** (hereinafter the "University") and **Ramakrishna Mission Hospital, Itanagar, P.O. R.K.M, Hospital, Itanagar – 791113, Arunachal Pradesh** (hereinafter the "Hospital").

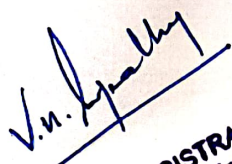
In continuation of the existing MOU dated 01/09/21, which is expiring on 30/8/24, both parties mutually decided to renew the existing MOU as per details given below:

WHEREAS, the University desires to provide supervised clinical or other fieldwork experience and instruction as part of its educational program for its students (the "Students"); and

WHEREAS, the Hospital, in the interest of furthering the educational objectives of the University, desires to make its facilities available to the students for such experience;

NOW THEREFORE, in consideration of the promises, the mutual covenant, agreements and undertakings hereinafter set forth, it is hereby AGREED;

1. **Planning of Educational Program:** The University shall be responsible for the planning, implementation and execution of all educational aspects of the students clinical or other fieldwork experience and instruction, including the requirements for promotion and graduation (the Program").
2. **Philosophy and objectives of the Program:** The University will convey to the Hospital information about the philosophy and objectives of the Program.
3. **Instruction and Supervision:** The Hospital shall plan and implement student assignments, *in consultation with the University in accordance with criteria developed by the University*. The University shall provide Faculty (the "faculty") for tracking student progress and for consultation with the Hospital, as necessary. The faculty shall be solely responsible for assigning a final course grade to the student.
4. **Notice of Program:** The University shall submit to the Hospital at least thirty (30) days prior to commencement of the clinical or fieldwork program a description of:
 - a) The types of clinical or fieldwork experiences needed.
 - b) The dates during which such experiences will be needed.
 - c) Number of students expected to participate in the clinical or fieldwork program.
 - d) Names, professional credentials and evidence of current licensure of Faculty who will supervise the students.
 - e) The University shall inform the Hospital, as soon as practicable, of any changes in information previously provided to the Hospital regarding the clinical or fieldwork program.
5. **Compliance with the Hospital Rules by Faculty:** The University will instruct its Faculty to comply with all rules and regulations of the Hospital. Upon the Hospital's request, the University agrees to withdraw promptly any member of the faculty who fails to comply.
6. **Compliance with the Hospital Rules by Students:** The University will instruct students to comply with all rules and regulations of the Hospital. Upon the Hospital's request, the University agrees to withdraw promptly any student who fails to comply.

15. **Term and Termination of Agreement:** The agreement shall be effective as of the date first written above and shall continue in effect for five (5) years. Thereafter, this agreement may be renewed for successive one-year term by the mutual written consent of the parties. Either party may terminate this agreement at any point of time without citing cause by giving Six (6) month written notice to the other party.
16. **Students and Faculty Not Employees or Agents:** Both the University and the Hospital acknowledges that neither students nor faculty are to be considered employees or agents of the Hospital.
17. **Governing Law:** The validity, construction, performance and effect of this agreement shall be governed by the Ramakrishna Mission Hospital.
18. **Entire Agreement and Amendment:** This Agreement is the entire agreement between the parties and supersedes and rescinds all prior agreements relating to the subject matter hereof. This agreement may be amended only in writing signed by both parties.
19. **Notices:** Any notice required to be given pursuant to the terms of this agreement shall be in writing and shall be sent to the Hospital or the University at the address set forth below. The notice shall be effective on the date of delivery indicated on the return receipt.
20. **Prohibition against Assignment:** Either parties, without the prior written consent of the other party, may not assign this agreement.

Effective Date and Signature

This MoU shall be effective upon the signature of authorized officials from Himalayan University and Ramakrishna Mission Hospital. It shall be in force from 01/09/2024.
